Purpose

Privacy Policy

Legal Basis for Processing

We collect and process personal data about users only when we have a legal basis for doing so.

We rely on the following legal basis to collect and process the personal data of users.

We may also collect the following data when you perform certain functions on our Site.

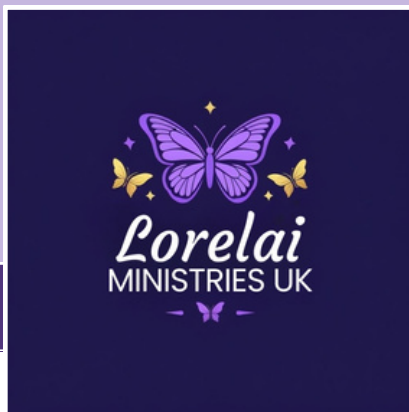

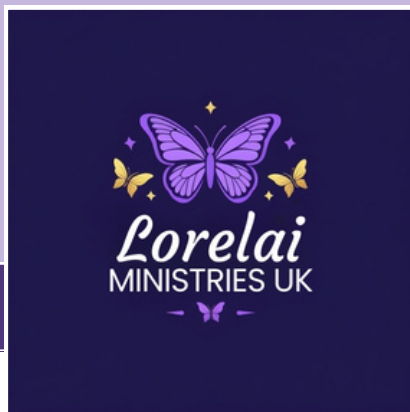
